University is going to conduct this entrance test on 25-08-2019. Advertisement for the same is being released shortly.

If you are willing to start Ph. D program at your institute and participate in entrance test being conducted by IKGPTU, the following terms and conditions shall be applicable:

1. University Notification No. IKGPTU/Reg/N/723 dated 09-12-2015 regarding "Guidelines governing of the UGC Autonomous Institutes", shall be applicable.
2. The admission of Ph.D. program of autonomous colleges shall be made through centralized admission/ test conducted by IKGPTU.
3. Ph.D. Regulations 2016 and amendments from time to time of the university shall be followed by the autonomous colleges.

4. Notification of PG programs being offered.
5. List of vacant slots of eligible supervisors (as per latest guidelines attached) in the prescribed performa attached herewith.
6. Research facilities certificate in the prescribed performa attached herewith.

The above documents must reach in the office of Dean (R&D) latest upto 13-08-2019 by 04:00 pm.
