# **Guidelines for Tuition Fee Waiver Scheme**

## Tuition Fee Waiver (TFW) Scheme (For Punjab resident candidates only)

- Sons/Daughters of parents whose annual income from all sources does not exceed **₹8.00Lakh**.
- The Waiver is limited to the Tuition Fee. All other Fees except Tuition Fee shall have to bepaid by the beneficiary.
- In the event of non-availability of students in this category, the same shall not be given to any other category of candidates.
- A student admitted under this scheme shall not be allowed to change the Institution/Course under any circumstances.
- Allocation of TFW seat is subject to the approved Intake sanctioned by affiliating university.
