Item No. 5.5 Annual Convocation

Annual Convocation is to be held during 2.4.2016. It is apprised that Annual Convocation for passed batch 2014 and 2015 could not be held due to visits by various agencies like NBA, NAAC etc.

Item No. 5.6 Variation of marks after re-evaluation

It is proposed that in case the variation of marks after re-evaluation is more than 30%, the same answer sheet will be referred for third evaluation and average of best two shall be awarded.

The item is placed before the Academic Council for approval.

Item No. 5.7 Variation of Syllabus

It is also proposed to set a single question paper for a particular subject pertaining to different study schemes applicable for various batches, if the variation in syllabus is not more than 15%. The syllabus of the latest scheme will be followed for setting the question paper for any particular subject. This will be applicable for both UG and PG Programmes.

The item is placed before the Academic Council for approval.

Item No. 5.8 Introduction of Flexible/Modular System

In the fourth academic council meeting held on 10.7.2015, a committee was constituted to deliberate on the matter but the meeting has yet not been convened as Affiliating University has implemented Credit Based System and institution has been directed to follow this system. After streamlining the newly introduced system, this matter will be again taken up in ensuing meeting.

The item is placed before the Academic Council for information.

Item No. 5.9 Matters related to academic governance

Following points are submitted for ratifications from Academic Council:

1. No Two examiners should be from same Institute in the Panel of External Examiners for M.Tech. Thesis viva-voce. All the four examiners should be from different Institutes; this will be applicable to both M.Tech. (AICTE & IKGPTU RC) courses.
2. At the most only two external Viva-Voce of M.Tech. Thesis can be evaluated by a single Examiner on particular day. Either two viva-voce of M.Tech. (AICTE)/M.Tech. (IKG PTU RC) or single viva –Voce of M.Tech. AICTE and M.Tech. IKG PTU RC will be permissible.
3. In an extra ordinary case of UMC etc. in respect of student (who has no further duration to complete his/her course), in that case, he/she will be provided a chance to appeal before the Head of Institution. The Head of Institution shall have right to re-consider his/her case based upon the gravity of situation on case to case basis. The final decision taken in such cases should be put up in ensuing meeting of Academic Council.
4. Credit Based system has been proposed for Thesis works for Batches 2014 Onwards. It is decided that from 2014 admitted batches and onwards, the thesis work will carry three hundred marks as detailed below.

A] Mid Term Evaluation = 100 marks (Report = 40, Presentation =20, Viva= 40)

B] End Semester Evaluation = 100 marks (Report = 40, Presentation =20, Viva =40)

C] External Examination = 100 marks (Report = 40, Presentation =20, Viva =25, Research Paper=15)

As IKG PTU Jalandhar has introduced the Credit Based System (CBS) vide letter No. IKGPTU/Reg/11677 dated 3/12/15 which is slightly different from grading system approved by the institute vide letter No. M.Tech/01/1793 dated 28/8/2014. Therefore to have equivalency with the grading system introduced by IKG PTU Jalandhar, Similar CBS system with absolute grading is proposed for PG Thesis work. The final grade will be the sum of marks of mid, end and external examination. The grading system as shown in Table 1 will be applicable for both M.Tech Full time and Part time (AICTE) courses.

5. Various distances has been fixed for claiming TA for external examiners coming to institute for conducting external viva voce exams. (Please Refer Annexure-VIII).
6. The number of slots to guide the M.Tech. Theses is as under
Professor – 08, Associate Professor- 06,
Asstt. Professor (with Ph.D.) - 05, Asstt. Professor (without Ph.D) - 04
This includes the combined number of candidates from both M.Tech. AICTE (FT/PT) & IKG PTU RC (PT). In case of combined supervision, load will be equally divided among the supervisors i.e. a load of 0.5 has to be considered for each supervisor.
7. It is proposed that from Batch 2014 & onwards for M.Tech.–AICTE (FT/PT) courses, the thesis report is to be submitted in spiral binding for external viva voce examination. The hard bind report will be submitted (after incorporation of any modification recommended by the External Examiner) after the final viva-voce exam.
8. It is proposed that any external viva of M.Tech. Thesis (AICTE & IKG PTU-RC) will be conducted at least after 10 working days from the date of the dispatch of the Thesis to the External Examiner by this office. No external viva will be conducted on gazetted holidays.



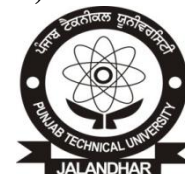

In item no. 5.9, sub item 4, the credit based system for PG was implemented from the batch 2014. It has come to the notice of the College that already IKGPTU has notified two result notification with old system instead of Credit Based System. It is therefore proposed that to avoid unnecessary hazards to students, this new system may be implanted w.e.f 2015 batch in PG programme as done in case of UG Programmes.

ITEM No. S 5.2 PROPOSAL TO START PG DIPLOMA/CERTIFICATE IN VLSI DESIGN

The Department of ECE proposes to start a six month PG Diploma course in VLSI Design and a three months certificate course in VLSI Design upgradable to PG Diploma.
