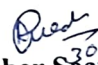

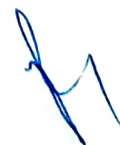

Item No. 12.03 Referring of 'UGC-CARE Reference List' (UGC-CARE List) instead of 'UGC Approved List of Journals' for awarding marks for external M.Tech. Thesis Evaluation

'UGC Approved List of Journals' has been replaced by 'UGC-CARE Reference List' (UGC-CARE List) vide public notice no.F.1-1/2018 (Journal/CARE) dated 16.09.2019 as per **ANNEXURE-3**. Keeping in view this, 'UGC Approved List of Journals' may be replaced with 'UGC-CARE Reference List' (UGC-CARE List) in M.Tech. External Examiner Report.

Item No. 12.04 Declaration of attempts in Backlog Certificate

Currently, the backlog certificate is issued to the students containing the total number of semesters crossed/elapsed between the regular examination and final reappear cleared examination by the student against a single subject. Keeping in view the student interest, only those attempts in which they have filled their reappear examination forms may be allowed.

The item is placed before the Academic Council for approval.

Item No. 12.05 Clearance of Detention

Students detained, due to shortage of attendance, in any course(s), are allowed to repeat the course(s) and can appear in the concerned course(s), whenever it/these is/are offered as a regular course(s). It is proposed that in case:

- a. Any particular course(s) is/are not being offered in the upcoming semesters (due to change of scheme) in the same/other departments, and
- b. Similar course(s) is/are also not being offered (syllabus content should be minimum 80% similar) in the upcoming semesters in same/other departments, then

Head of Department may allow the student(s) to study the detained course(s) in the upcoming semester.

The item is placed before the Academic Council for approval.

Item No. 12.06 Re-admission of Students

As per IKGPTU norms, "The Principal is authorized to do the readmission of the student/s after a gap in their course but it must be as per the University norms. The approval of all such candidates will be taken from the University prior to the next examination session in one go."

For such cases, following procedure is proposed:-

- Student has to submit an application for readmission in his/her concerned department; along with the application, a gap certificate (in original) duly attested by the Notary Public and all the result notifications have to be enclosed.
- The case may be reviewed and recommended by a committee approved by the Principal.
- Finally, after the case has been provisionally approved by the Principal, the student will have to deposit Rs. 2500/- as readmission charges and full fee of the applicable semester of readmission.

Item No. 12.13 Amendment in policy regarding third evaluation

Following are the rules for third evaluation of answer sheet at present:-

In case the variation of obtained marks after re-evaluation is more than 35%, the same answer sheet may be referred for third evaluation subject to the condition that either the marks obtained in first evaluation or in the second evaluation (i.e. first re-evaluation) is more than 30%. In case third evaluation is done, then average of best two obtained marks shall be awarded.

It is proposed that:

1. Third evaluation will not be undertaken, in case applicant does not pass (marks are less than 40%) in any of the two evaluations.
2. Third evaluator will be external, with 10 years of teaching experience or Associate Professor or higher rank.
3. Marks will be calculated on following basis:
 - Identify outlier, if there is any. [Outlier: Find average of marks of all three evaluations (A), average of top two marks (T), and average of bottom two marks (B). If B and T lies within 20% of A, then there is no outlier.
 - If there is no outlier, then result will be average of three obtained marks.
 - If any one (T or B) is more than 20% of A, then reject that, and result will be non-rejected value.
 - If both T and B vary more than 20% of A, then reject T or B with more variation, and result will be non-rejected value.

Item No. 12.14 Amendment in eligibility criteria of question paper setter

Currently, the experience of a teacher to become eligible for setting up of question paper is 3 years for teaching in the same subject.

It may be allowed that teacher must have at least two years of teaching experience (including on-going semester) in total and he / she must have taught the concerned subject (or its contents) at least for two semesters (including on-going semester). Moreover, if a teacher has teaching experience of greater than or equal to five years, then he/she may be allowed to set the question paper of any subject of his/her field at UG level.

- (ii) Such students can appear in maximum 10 theory and practical (both external only) examinations in two end semester examinations and may opt for maximum 5 papers in one session of examination.
- (iii) Fee of Rs. 5000/- per paper shall be charged.
- (iv) Single opportunity shall be given to a student for exercising the option of improvement in grade.

Result shall be declared only if the attempt of student is sufficient enough for change in his/ her already awarded grade. A student shall be awarded maximum upto "A" grade only and in "O" grade shall not be awarded in any circumstances.

Revision of the remuneration for question paper setting

During every End Semester Examination, the Examination Branch receives complaints about questions of some Question Papers (like wrong / incomplete statements, missing data, out of syllabus etc.). To check the genuineness of the complaints, against Question Papers, these cases are sent to external experts.

Remuneration of Rs. 500/- per question paper may be allowed for the external expert for reviewing and giving comments on complaint.

The above proposal has been approved by Chairman Academic Council in anticipation to the approval of the Academic Council as per **Annexure-12**.
