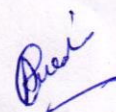

Internal assessment criteria related to Training-I (TR-101) and Training-II (TR-102) of B.Tech. (2018 scheme) for session July, 2020 to Dec.,2020:

1. The internal evaluation of Training-I (TR-101) and Training-II (TR-102) (Total 60 marks) of B.Tech. (2018 scheme) shall be as per following criterion:

Activity	Maximum Marks
Certification exam by Spoken Tutorial, IIT Bombay	20
Other evaluation criteria	40

2. The students have to clear the certification exam conducted by Spoken Tutorial, IIT Bombay in order to get marks out of 20. For those students, who have cleared the exam, the evaluation will be based on their percentage marks awarded in the certification exam. For example, if a student got 80% marks in certification exam, then he/she will be given 16 marks (80% of 20=16) out of maximum 20 marks. If he/she has not appeared/not qualified the certification exam, then zero marks out of maximum 20 marks will be awarded. For such students the internal evaluation will be based on the remaining 40 marks (60-20=40) only. Only one best examination marks out of Online Tests conducted by Spoken tutorial should be considered for the final evaluation (i.e. 20 marks).

- Point-I The student who have undergone offline training, Internship & Online/Offline training in PSUs, Govt. organizations etc. will be exempted from online course.
- Point-II 20% of 90 marks (Assessment by visiting faculty component) will be deducted for those students who have neither completed online course nor did training as per mentioned in Point-I by internal examiners.

13.13.12 End Semester Examination related matters

1. Pattern of question papers for UG (Regular for outgoing batches), UG/PG (reappear) ESE May-2020, makeup examination of Nov-2019 session, Online mode, Open Book Examination

The question pattern of UG and PG classes will have a total of 50 questions in the paper having two sections. Section-A- 40 questions of 1 mark each, Section-B- 10 questions of 2 marks each. Total marks of the question paper will be 60. Duration of examination: 2 hours. All questions will be objective type like MCQ, fill in the blank, true/false, match the following, drop down, numerical answer type etc. However, for result preparation, the marks obtained by students are scaled to match the study scheme.

There will be no negative marking.

Overall choice for the students in the question paper is 25%. That is, out of 60 marks, students have to attempt for at least 45 marks combined from section-A and section-B.

2. Pattern of question papers (UG and PG) for regular ESE Nov- 2020 Online mode (excluding 2020 admission)

All questions will be objective type questions (like MCQ, fill in the blank, true/false, match the following, drop down, numerical answer type etc.).

There will be no negative marking. Duration of examination will be 2 hours.

Overall choice for the students in the question paper is 20%. That is, out of 60/100 marks, students have to attempt for at least 48/80 marks respectively for UG/PG exams combined from all sections.

a) Pattern of UG question paper

A total of 50 questions in the paper having two sections. Section-A- 40 questions of 1 mark each, Section-B- 10 questions of 2 marks each

b) Pattern of PG question paper

The question paper will consist of 1 mark, 2 marks, 3 marks and 4 marks questions in any combination, such that total marks of all the questions matches with maximum marks allotted to the subject. One such combination for a question paper of 100 marks is Section-A will have 10 questions of 1 mark, Section-B 10 questions of 2 marks each, Section-C 10 questions of 3 marks each and Section-D will have 10 questions of 4 marks each.
