The Society is following a programme of giving scholarships since the year 1987-88 to needy students getting vocational / professional education. We now invite applications for the grant of scholarships to needy students studying in professional / vocational courses for the current academic year 9013-19. Merit, cum means as well as physical disability status will be the main considerations. The scholarship scheme is explained below:-

- A) ELIGIBILITY : The criteria for eligibility shall be as under:
  - i) Student with a minimum of 60% marks in the previous examination passed can apply.
  - ii) Income of the parents of the student (both father & mother) should not exceed Rs.10000/- p.m. (exclusive of House Rent Allowance and Fixed Medical Allowance in the case of employees / pensioners).
