7. Train the persons deputed by the Employer for safe and efficient operation of the STP.
8. Provide two copies of the standard operational procedure manual and prescribed maintance schedule as required for an efficeint operation of the STP.
9. Ensure safeties of all persons deputed for the execution of the STP and its subsequent operation; the contractor will take all precautions to avoid accidents at the site/STP. The contractor will be wholly responsible for any mishap/accidents occurring at the site during the construction and subsequently during the operations.
